- 4. Services are to be rendered on as "as needed" basis and shall be furnished 7 days a week within 2 hours of notification. The district and school parking lot will be the vendor's priority customer.
- 5. The term of this agreement shall be from <u>November 1, 2017</u> to <u>April 30, 2018</u>, but may be terminated on thirty (30) days written notice by either party to the other.
- 6. The vendor shall provide the District with detailed invoices, within 30 days of the date of service for payment approval at the next regular Board of Education meeting.
- 7. The vendor shall provide the following documents to the District prior to rendering any services:
 - a. IRS Form W-9
 - b. New Jersey Business Registration Certificate
 - c. Affirmative Action Questionnaire or Certificate of Employee Information
 - d. Chapter 271 Political Disclosure Form
 - e. General Liability Insurance in the minimum of \$1,000,000 naming the Franklin Township School District as the Certificate Holder.
 - f. Automobile Liability Insurance covering any vehicle used by the Vendor.

- g. Evidence of adequate Workers Compensation Insurance as required by the State of New Jersey, minimum \$1,000,000 Each Accident.
- 8. The contractor shall assume all risk of and responsibility for, and agrees to indemnify, defend, and save harmless the Board and its agents, employees and Board members, from and against any and all claims, demands, suits, actions, recoveries, judgments and costs and expenses (including, but not limited to, attorneys fees) in connection therewith on account of the loss of life or property or injury or damage to any person, body or property of any person or persons whatsoever, which shall arise from or result directly or indirectly from the work and/or materials supplied under this contract and the performance by contractor of services under the contract or by a party for whom the contractor is liable. This indemnification obligation is not limited by, but is in addition to, the insurance obligations contained in this agreement.
- 9. The Contractor is to assume all liability incident to the work, including property damage caused by him or his men or by any subcontractor employed by him or any of the subcontractor's men.
