Mr. Burdick read a statement about Superintendent tenure at Franklin Township School, and use of NJSBA for search.

2013 - Dr. Davis couldn't take the job. We hired Dr. Fredericks without a formal search. We also have an issue with turnover of SBA.

2018 - Posted ad for 8 days. 17 applicants with over 40 data points. We spent over 20 hours doing research.

March 30, 2018 is the target date to appoint.

Comments from Public/Parents (14 comments) 9 to not follow process. 5 to follow the process.

## 2. Public Comments - Privilege of the Floor (3 minutes)

• Amy Gilpin - Asked for an explanation of the 9 and 5 comments. Mr. Burdick explained that 9 said not to advertise; just appoint. Five said to do the whole process. Mr. Burdick further explained we looked to share and that process ended without a share. On February 14, 2018, NJSBA is conducting a meeting to solicit comments. Mrs. Gilpin said ad was generic; want their vision, and if Franklin Township School is a good fit. History with turnover so we should take extra care and time in selecting a superintendent.

• Mrs. Crielly said she e-mailed her concerns to all BOE members. It is important to do a search and go through the process. Franklin Township School is small and might be a stepping stone to a larger district.

• Mrs. Forbes said we should follow the process. Dr. Davis is a good guy and atmosphere has changed. We need someone who is a leader and will guide the district and hire/fire, etc.

• Mr. Repmann said to follow the process; due diligence is important. There is no working knowledge of the candidates being interviewed. We have someone we know, how does that factor into the decision?

• Mrs. Luciano said she appreciates all of the comments. We have done it both ways and still have a high turnover. The process is not broken.

• Mr. Crielly said it's not about circumventing the process. In a unique circumstance with Dr. Davis. But he is at the end of his career and maybe we will find a good candidate. The window to apply was too small.

• Mr. Repmann suggested a longer contract. Mr. Burdick said the term clause binds the Board of Education, not the candidate.

• Mr. Cama added to Mrs. Crielly's comment. We are hiring our CEO; bringing new ideas; looking toward the future. Sharing was a different process. We should do our due diligence - we are looking for our future leader.

• Mrs. Sutton said she invested over 20 hours reviewing candidates and is also looking for the best fit for Franklin Township School.
