RESOLUTION NO. 57-2015 AUTHORIZING SEWERAGE RATES AND CHARGES FOR SECOND, THIRD AND FOURTH QUARTERS OF 2015 AND FIRST QUARTER OF 2016

Councilmember Leckstein introduced and offered for adoption the following Resolution; seconded by Councilmember Kelly;

WHEREAS, the Governing Body of the Borough of Sea Bright authorized the rates and charges of the municipal public utility for sewerage for the second, third and fourth quarter of 2015 and the first quarter of 2016.

WHEREAS, any previous schedule of charges adopted by the Mayor and Council of the Borough of Sea Bright which are inconsistent herewith are hereby rescinded.

WHEREAS, the rates and charges for the utilities are as follows:

- 1. The 2015 second, third and fourth and 2016 first quarter sewerage rate will be at the rate of \$9.90 for every 1,000 gallons of water consumed by the customer.
- 2. The charges shall be due and payable in 2015 and 2016 within 10 days after the due date of the municipal sewer utilities bill. If the bill is not timely paid, the outstanding bill shall be considered a municipal charge and shall be subject to the same rate of interest accruing on delinquent taxes. The second quarter billing in 2015 shall be mailed during July of 2015 which will be for consumption billed by the water company from mid March thru mid June. The third quarter billing in 2015 shall be mailed in October for consumption billed by the water company from mid June thru mid September. The fourth quarter 2015 billing shall be mailed in January 2016 for consumption billed by the water company from mid September thru mid December. The first quarter billing in 2016 shall be mailed during April 2016 for consumption billed by the water company from mid December 2015 thru mid March 2016.
- 3. Consumption shall be based upon the information provided to the Borough of Sea Bright Municipal Sewer Utility by the New Jersey American Water Company. The customers that are billed by the New Jersey American Water Company on a quarterly basis shall have their sewer charge based upon the quarterly water charges from New Jersey American Water Company. Those customers that are billed on a monthly basis by New Jersey American Water Company shall have their bills based upon their water consumption.
- 4. All customers of the municipal sewer utility shall be billed for at least 10,000 gallons quarterly. This minimum charge shall be \$99.00 for the second, third and fourth quarters of 2015 and the first quarter of 2016.
- 5. The consumption charges shall be billed to the metered townhouse or condominium association or corporation for payment.
- 6. If any section, subsection, clause or provision of this Schedule of Charges shall be adjudged unconstitutional or to be ineffective in whole or in part, to the extent that it is not adjudged unconstitutional or is not effective, it shall

be valid and effective; and no other section, subsection, clause or provision of this Schedule of Charges shall on account thereof be deemed invalid or ineffective and the inapplicability or invalidity of any section, subsection, clause or provision of this Schedule of Rates and Charges in any one or more instances or under any one or more circumstances shall not be taken to affect or prejudice in any way its applicability or validity in any other instances or under other circumstances.

7. A copy of same shall at all times be kept on file at the office of the Tax/Sewer Utility Collector at 1167 Ocean Avenue, Sea Bright, New Jersey and shall at all reasonable times be open to public inspection.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Sea Bright that the utility is hereby authorized to publish a notice of final adoption of said Resolution of Rates and Charges.

BOND ORDINANCE No. 02-2015 AMENDING BOND ORDINANCE NUMBER 10-2012 FINALLY ADOPTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SEA BRIGHT, NEW JERSEY ON AUGUST 7, 2012

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SEA BRIGHT, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than two-thirds of all the members thereof affirmatively concurring), AS FOLLOWS:

- Section 1. The Bond Ordinance of the Borough Council of the Borough of Sea Bright, in the County of Monmouth, New Jersey (the "Borough") entitled "Bond Ordinance Providing An Appropriation Of \$1,850,000 For The Hazard Mitigation Project Bulkheads And Pump Station For And By The Borough Of Sea Bright In The County Of Monmouth, New Jersey And, Authorizing The Issuance Of \$452,235 Bonds Or Notes Of The Borough For Financing Part Of The Appropriation" finally adopted on August 7, 2012 (the "Ordinance") is hereby incorporated by reference in its entirety.
- Section 2. The Ordinance is hereby amended by (a) deleting the reference of "\$1,850,000" for the appropriation and estimated cost and "\$452,235" for the estimated maximum amount of bonds or notes and substituting in lieu therefore "\$2,150,000" and "\$737,235", respectively and by (b) deleting the reference to "\$23,801" for the down payment required by the Local Bond Law and substituting in lieu therefor "\$38,801".
- Section 3. The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolutions in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.
- Section 4. This Section 4 constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The Borough reasonably expects to pay expenditures with respect to the Improvements prior to the date that the Borough incurs debt obligations under this Bond Ordinance. The Borough reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the Borough under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the costs of the Improvements is \$737,235. All other provisions of the Ordinance shall remain unchanged.
- Section 5. This amendatory bond ordinance shall take effect twenty days after the first publication thereof after final adoption as provided by Local Bond Law.

ORDINANCE NO. 03 – 2015 AN ORDINANCE REVISING CHAPTER 115, <u>FLOOD DAMAGE PREVENTION;</u> and REVISING CHAPTER 130, <u>LAND USE</u>

WHEREAS since the events of Superstorm Sandy, the Borough of Sea Bright has been working toward creating a more sustainable community in line with guidelines set by the Federal Emergency Management Agency (FEMA); and

WHEREAS in furtherance of the Borough's efforts, certain recommendations have now been made by the Borough's Floodplain Manager and the Borough's Office of Emergency Management as to changes which should be made to the Borough's Flood Damage Prevention and Land Use Ordinances; and

WHEREAS in furtherance of the aforesaid recommendations the Mayor and Council of the Borough of Sea Bright have determined it will be necessary to revisit certain definitions and requirements within its flood damage prevention and land use ordinances;

BE IT NOW ORDAINED, by the Mayor and Council of the Borough of Sea Bright that the following revisions to Chapter 115, <u>Flood Damage Prevention</u> and Chapter 130, <u>Land Use</u> be made:

- The following language included at Chapter 115, Section 115-17(A)(1)(b)[1], Chapter 115, Section 115-17(B)(1)(b)[1], Chapter 130, Section 130-47(E)(2)(a)[2][a], Chapter 130, Section 130-47(E)(2)(b)[2][a], Chapter 130, Section 130-50(A)(6)(c), Chapter 130, Attachment 1 "Schedule of Lot and Building Requirements", footnote 2 and Chapter 130, Section 130-59(A)(6)(a) shall be deleted: "reach two (2) feet above BFE" and said language shall be replaced with "reach three (3) feet above BFE".
- (2) The following definitions shall be added to Chapter 115, Section 115-5 and to Chapter 130, Section 130-47(B):
 - (A) <u>FLOOD INSURANCE RATE MAP (FIRM) See definition of Digital Flood Insurance Rate Map (DFIRM).</u>
 - (B) PRELIMINARY WORK MAPS (PWM) The preliminary work maps created for certain New Jersey/New York communities by the Federal Emergency Management Agency (FEMA) in the development of Preliminary Flood Insurance Rate Maps. The preliminary work maps reflect the full results of an ongoing coastal flood hazard study for the New York/New Jersey coast by FEMA.
 - (C) PRELIMINARY FLOOD INSURANCE RATE MAP A Flood Insurance Rate

 Map (FIRM) that is not yet effective and reflects the initial results of a flood map

 project performed by or for FEMA.
 - (3) The definitions of "Base Flood Elevation (BFE)", "Digital Flood Insurance Rate Map (DFIRM)", and "Prevailing NFIP Flood Map", as contained within Chapter 115, Section 115-5 and Chapter 130, Section 130-47(B), shall be deleted and replaced with the following definitions:

- from a flood that has a 1% chance of equally or exceeding that level in any given year. The BFE is promulgated by the Federal Emergency Management Agency (FEMA) and delineated on the Digital Flood Insurance Rate Map (DFIRM). However, if FEMA has released Advisory Base Flood Elevations (ABFEs) or Preliminary Work Maps (PWMs) post release of the official DFIRM, all elevations and zones included on the ABFE map or PWM, which ever was created later, shall be recognized by the Borough as the official BFEs. In the event any property within the Borough has not been delineated with an elevation on the DFIRM, ABFE or PWM, whichever is prevailing at the time, then the Borough shall recognize that property's BFE as being the same as the elevation delineated within the nearest adjacent "AE" Zone.
 - (B) DIGITAL FLOOD INSURANCE RATE MAP (DFIRM) The official map on which the Federal Emergency Management Agency (FEMA) has delineated the areas of special flood hazards and the risk premium zones applicable to the community. However, if FEMA has released Advisory Base Flood Elevations (ABFEs) or Preliminary Work Maps (PWMs) post release of the official DFIRM, all elevations and zones included on the ABFE map or PWM, which ever was created later, shall be recognized by the Borough instead of those contained on the official DFIRM. The definition of DFIRM shall be interchangeable with the Flood Insurance Rate Map (FIRM) for the purposes of this ordinance.
 - (C) PREVAILING NFIP FLOOD MAP The Digital Flood Insurance Rate Map (DFIRM) as defined by this Ordinance with Advisory Base Flood Elevations (ABFEs) or Preliminary Work Maps (PWM), which ever was created later, prevailing if any have been released by the Federal Emergency Management Agency.

BE IT FURTHER ORDAINED all other sections of Chapter 115 and Chapter 130 shall remain in full force and effect. In the event there is any conflict or inconsistency between this particular ordinance and the rest of Chapter 115 and Chapter 130, the terms in this ordinance shall prevail.

This ordinance shall take effect upon passage and publication as required by law.

ORDINANCE NO. 04-2015 CALENDAR YEAR 2015

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 1.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Sea Bright in the County of Monmouth finds it advisable and necessary to increase its CY 2015 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 3.5 % increase in the budget for said year, amounting to \$68,609.36 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Sea Bright, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2015 budget year, the final appropriations of the Borough of Sea Bright shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$120,066.38, and that the CY 2015 municipal budget for the Borough of Sea Bright be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
