BOND ORDINANCE NO. 21-2019

AN ORDINANCE PROVIDING FUNDING FOR VARIOUS CAPITAL ACQUISITIONS FOR THE BOROUGH OF SEA BRIGHT AND APPROPRIATING \$100,000 FOR SUCH PURPOSE.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SEA BRIGHT, IN THE COUNTY OF MONMOUTH AND STATE OF NEW JERSEY, AS FOLLOWS:

- <u>Section 1</u>. The Borough of Sea Bright, in the County of Monmouth, New Jersey, authorizes for various capital acquisitions, including the acquisition of computers, electronic equipment, furniture and other office equipment for the Police Department, Administrative Department, the Department of Public Works and Fire Department for the Borough of Sea Bright, to be funded from the sources specified in Section 2 of this Ordinance.
- Section 2. The amount of \$100,000 is hereby appropriated for the purposes stated in Section 1 of the Ordinance and which amount was funded from the FEMA Disaster Recovery Municipal Facilities Project Fund in the amount of \$75,000 and from the Borough's General Capital Improvement Fund in the amount of \$25,000.
- Section 3. In connection with the purpose and the amount authorized in Sections 1 and 2 hereof, the Borough determines the purpose described in Section 1 hereof is not a Current Expense and is an improvement which the Borough of Sea Bright may lawfully make as a general improvement.
- Section 4. All ordinances or parts of ordinances which are inconsistent with the terms of this Ordinance be and the same are hereby repealed to the extent of their inconsistency.
- Section 5. This Ordinance shall take effect immediately upon due passage and publication according to law.

I HEREBY CERTIFY this to be a true and correct Bond Ordinance No. 21-2019 of the Mayor and Borough Council of the Borough of Sea Bright, introduced on September 17, 2019 and will be further considered after a Public Hearing held on October 1, 2019 at the Municipal Building, 1097 Ocean Avenue, at 7:00 pm.
