

**RESOLUTION NO. 25-2025**  
**AUTHORIZING CONTRACT EXTENSION FOR**  
**PROFESSIONAL SERVICE CONTRACT**  
**INFORMATION TECHNOLOGY CONSULTANT**  
**INTRON TECHNOLOGY**

**WHEREAS**, the Mayor and Council of the Borough of Sea Bright approved Resolution No. 21-2024 on January 6, 2024, awarding a professional services contract to Intron Technology Solutions, LLC, Little Silver, New Jersey, to serve as the Information Technology Consultant for the Borough of Sea Bright; and

**WHEREAS**, the professional services contract was for one (1) year, commencing on January 1, 2024 through December 31, 2024 with the option of additional one year extensions up to a total term of seven years, as permissible per N.J.S.A. 40A:11-15(5); and

**WHEREAS**, the Borough Council of the Borough of Sea Bright wishes to exercise the first one-year extension option to continue the professional services contract for Information Technology Consultant with Intron Technology Solutions, LLC, which will expire on December 31, 2025.


