WHEREAS, Mr. Padula has advised the Borough Administrator that he is no longer with the firm of Cleary, Giacobbe, Alfieri, Jacobs, LLC, and has started a new firm, Padula Law Group, LLC; and

WHEREAS, the Borough wishes to appoint Bruce W. Padula, of the firm Padula Law Group, LLC, to serve as Borough Labor Attorney at a rate not to exceed \$185.00 per hour; and
